WHO ARE THE LAWYERS AND ORGANISATIONS ELIGIBLE FOR FREE LISTING?

The following UK lawyers are classified as lawyers in BLD:

- Solicitors (on the roll, whether or not practising solicitors)
- Barristers (whether or not practising barristers)
- Licensed Conveyancers with full or limited licence
- Registered European Lawyers (REL)
- Registered Foreign Lawyers (RFL)
- Fellows of the Institute of Legal Executives.

All organisations whether in private practice, commerce and industry, the public sector, academic institutions, charities or the not-for-profit sectors, and legal groups and associations are eligible provided they have at least one black minority ethnic lawyer.

HOW LONG WILL IT TAKE TO GET LISTED?

Registration will only take a few minutes and your information is saved once you click saved and finished. Also once you have completed the crucial information part of the registration you can save and finish and complete your full registration later. To save time you can upload your information in the form of a Vcard, if you have any. It is easy to save your contact information in Microsoft outlook as a Vcard.

YOUR LISTED PROFILE AND AMENDING OR UPDATING YOUR PROFILE

When you get listed, it is possible that when inputting information about your organisation, you will omit important information such as the type of organisation you are, the kind of work you do or any panel membership or you may make mistakes when inputting the information and realised this after saving and finishing your profile. Such omissions or mistakes can affect the result of any searches made if the information sought is missing from or incorrect in your profile.

However, you can correct this easily by amending or updating your information at anytime, 24 hours a day, 7 days a week by clicking the Members' Login icon (the pen) and then inputting your username (your email address) and your chosen unique password. To update your personal details and information click on the Account Details link - this is above your Contact Details and Address. Amend the relevant details and click update at the bottom of the page and your changes will be immediately made.

To amend or update information about your membership of panels, languages spoken, lawyer type and the type of work you undertake, click on "My Profile" link which is above your Contact Details and Address. Amend the relevant details and click update at the bottom of the page and your changes will be immediately made.

FORGOTTEN PASSWORDS

If you have forgotten your password, click on Members Login (the pen) and then click on the link: forgotten password. Input your email address and submit. Your password will be sent to you immediately.

SEARCHING FOR A LAWYER

Searches can be made using the Find a Lawyer search in the top right hand corner of each page, by location or type of law. Searches can also be made by using the keyword search which is next to the Members Login icon (pen) on every page.

FINDING YOUR WAY ROUND THE SITE

In the unlikely event that you are unable to easily find your way around the site, click on the Site Map link on the Homepage to find the location of the information you are seeking. You can also find the Site Map within our About Us pages.
